How the system works:

A.M. SERVICE: The morning route is serviced every hour Monday through Friday from 4:50 a.m. to 11:35 a.m. Starting in St. Helens, this line travels through Scappoose stopping at central business, school, and shopping areas, ending in Portland, with return trips every hour beginning at 5:43am until 8:43 a.m., with one stop at Sauvie Island at 10:38 a.m.

P.M. SERVICE: The afternoon route runs every hour, Monday through Friday, beginning at 12:30 and ending at the St. Helens Transit Center at 7:30 p.m.



Tips for Riding the Bus

- Please be at your stop 5 minutes early to help us better service you and others.
- You can also flag the bus down at any location titled "Flag Stop". If you plan to catch the bus one of these stops, please call our office so the driver can be alerted to look for you.
- **Please be ready to pay your fare when you board, with exact cash or a ticket. Drivers do not carry change.**
- Service animals are the responsibility of the owner and must be on a leash or in a carrier at all times.
- Max of 5 carry-on items allowed.

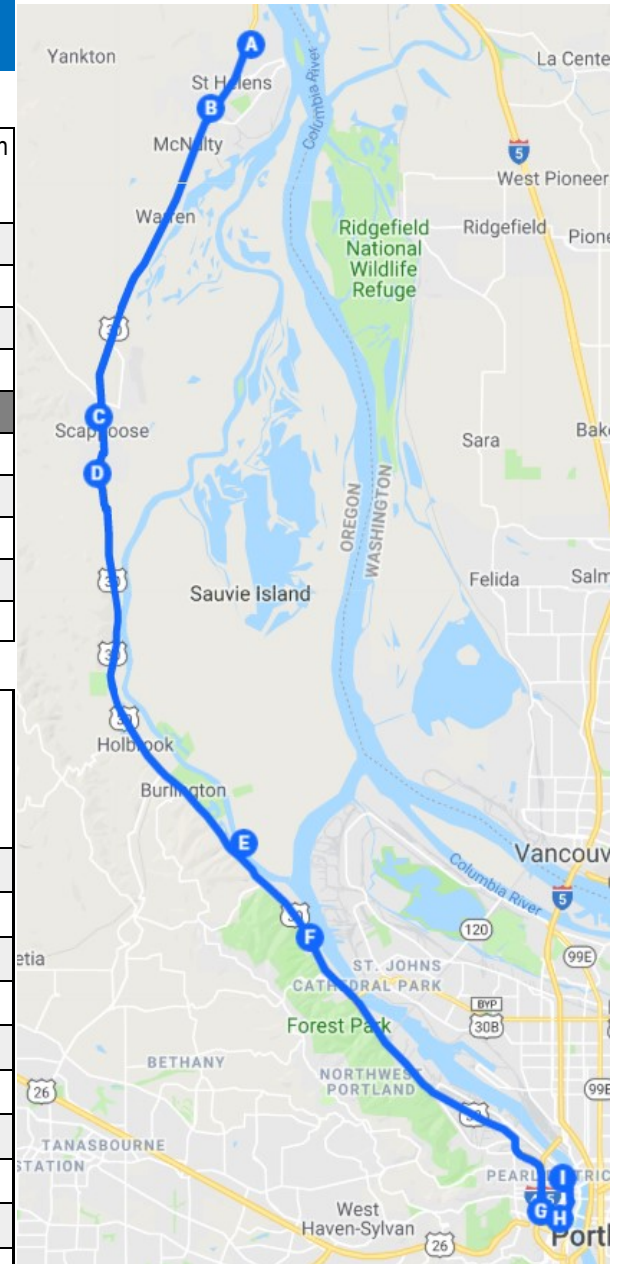
