Step #2: Install the Zoom software on your mobile device, or join in a web browser

Step #3: If prompted, enter the Meeting ID number: 84203959772

Note: Your device will automatically be muted when you enter the online meeting. At the time of public testimony, when prompted you may choose to select the option within the ZOOM software to "raise your hand" and notify staff of your desire to testify. Your device will then be un-muted by the Host, and you will be called upon, based on the name you entered within the screen when you logged in.

Jim Knight, a Senior Consultant with SDAO will facilitate the Board through this assessment. Here is the email that he sent you on Tuesday:

My name is Jim Knight, and I am a Senior Consultant with the Special Districts Association of Oregon (SDAO). It is my privilege to be your facilitator for your upcoming Board Meeting (July 28,11:30 AM) in which the Board will participate in the "Board Practices Assessment" or "BPA". This is a facilitated discussion that assists SDAO member boards with a self-evaluation of your perceptions of the performance of your organization in six key elements, they are:

- Duties and Responsibilities
- Operational Compliance
- Budget and Finance
- Customer Relations
- Personnel Administration
- Policies and Procedures

Attached, you will find the questionnaire that will help guide us through our discussions. Please take a moment to review the questions and consider your individual perceptions of those questions in preparation for our upcoming meeting. The questionnaire is yours to keep and is simply a guide to help you think about how well the Board and the organization are performing in the six key areas. You are welcome to make your own notes regarding your perceptions but the document itself is not turned in to anyone. The great value in the BPA process is having the ability to share your thoughts and listen to the perceptions of the other board members. Each category contains a "Rating" - GOOD; CAUTION; DANGER. My role will be to facilitate your discussions toward obtaining a board consensus of how the board feels they are performing.

If you are a relatively new board member, you will find this process very helpful in understanding how others feel about the Ratings in each category. New board members frequently help existing board members in learning about perceptions from outside of the board. Our overarching goal through this process is to assist your organization in focusing on what is working well and what areas need some attention. SDAO's desire is to simply help our member districts become the best they can be in serving the needs of their community and fulfilling their mission.
