### How the system works:

Fixed Route service operates Monday through Friday with one morning run and one afternoon/evening run. Each run leaves the St Helens Transit Center with stops going to and from Portland in St Helens, Scappoose and Linnton. After a stop at Lincoln Hugh School, the final downtown Portland stop is located on the south side of Salmon Street between SW 5th and SW 6th Avenues.



### Tips for Riding the Bus

- Please be ready 15 minutes early to help us better serve you and others.
- **Please be ready to pay your fare when you board, with exact cash or a ticket. Drivers do not carry change.**
- Service animals are the responsibility of the owner and must be on a leash or in a carrier at all times.
