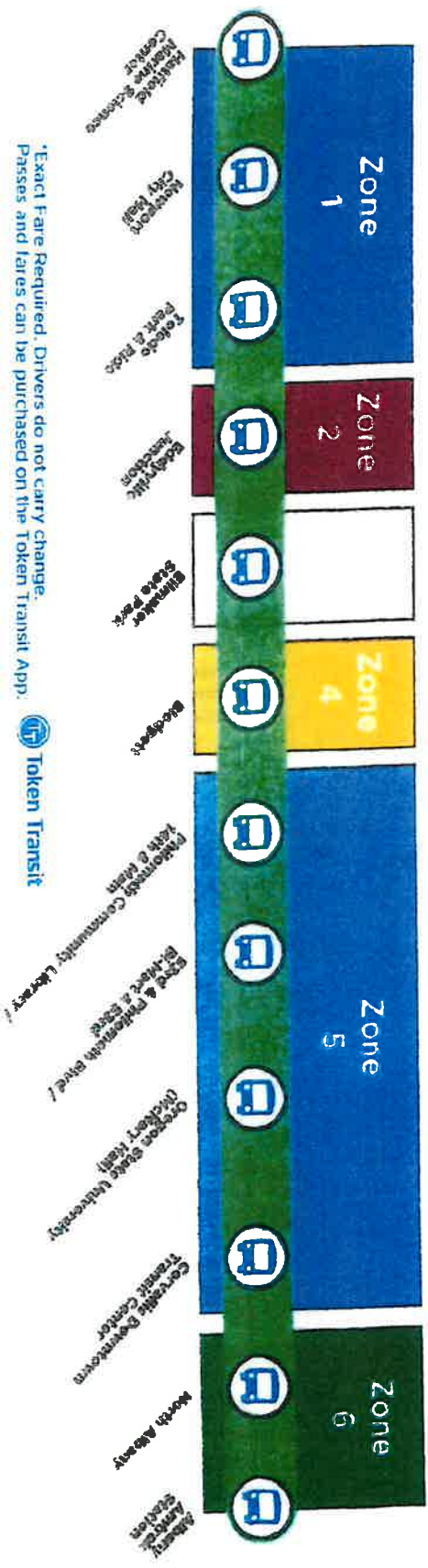


Coast to Valley Express Fare Schedule

NW CONNECT OR Coastal Visitor Passes

These passes entitle you to the following:

- One trip to/from the Oregon Coast
- Unlimited rides up and down the coast on SETD, TCTD, and Lincoln County's coastal routes during the period for which the pass is valid.
- Each adult with a valid visitor pass can be accompanied by a child up to age 16 at no additional charge.

You may purchase passes directly from the driver, through the Transit App, or by calling Benton County Public Works at 541-766-8821.
